Critical Use Comments:

- Only apply with shielded sprayer between the crop rows or near other emerged crops to avoid crop damage from direct spray and drift.
- After the first application, if the control is less than adequate and resistance is expected then the second application should not be applied.
- Add wetter at recommended rates.

Withholding Period:

Not required when used as directed.

Jurisdiction:

All states.
