



**PERMIT TO ALLOW MINOR USE OF AN AGVET CHEMICAL PRODUCT
FOR THE CONTROL OF GRASS WEEDS IN PARSNIPS
PERMIT NUMBER – PER11348**

This permit is issued to the Permit Holder in response to an application granted by the APVMA under section 112 of the Agvet Codes of the jurisdictions set out below. This permit allows a person, as stipulated below, to use the product in the manner specified in this permit in the designated jurisdictions. This permit also allows any person to claim that the product can be used in the manner specified in this permit.

Products to be used:

FARMOZ PLATINUM HERBICIDE
SELECT HERBICIDE
PLUS OTHER REGISTERED PRODUCTS

Containing: 240 g/L CLETHODIM as their only active constituent.

Directions for Use:

Crop	Weeds	Rate
PARSNIPS	Grass weeds including Winter grass (<i>Poa annua</i>)	150-500 mL product per hectare. Always apply with D-C-Trate at 2L/100L or Hasten at 1L/100L or Kwicken at 1L/100L or Uptake at 500mL/100L.

Critical Use Comments:

DO NOT apply without an addition of an oil.

DO NOT apply more than one application per crop.

APPLY only when grass weeds are between 2nd-leaf and fully tillered.

APPLY using ground application equipment in a minimum of 50 L per hectare water.

The rate selected between 150-500mL/ha should be determined by selecting the relevant rate for the weeds to be controlled as recommended on the product label.

Withholding Period:

DO NOT harvest for 28 days after application.

Jurisdiction:

ACT, NSW, QLD, SA, TAS, WA & NT only.

(Note: Victoria is not included in this permit because their 'control-of-use' legislation means that a permit is not required to legalise this off-label use in VIC).

Additional Conditions:

THIS PERMIT provides for the use of a product in a manner other than specified on the approved label of the product. Unless otherwise stated in this permit, the use of the product must be in accordance with instructions on its label.

PERSONS who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit.

EXPORT OF PRODUCE

Exported produce or animals must have appropriate residue tolerance limits established in the importing countries and any residues must not exceed the tolerance limits.
